- * The investments were made pursuant to Government Code Sections 53601, 53635 and comply with the County Treasurer's Statement of Investment Policy. The investment policy provides for:
 - Preservation of capital through high quality investments;
 - Maintenance of sufficient liquidity to meet participant operating needs; and
 - A rate of return consistent with the above objectives.
- * Maturities are scheduled to meet participant expenditure requirements for the next six months.
- * Attached spreadsheets identify investment type, issuer, maturity date, amount invested and fair market value for each security held. Fair market values were determined by Wells Fargo Institutional Trust Services on all securities except for investments in the Local Agency Investment Fund which was valued at face value by us. Adjustments have been made for premiums, discounts and accrued interest on discount securities to make the book value and fair market value more comparable.







1. Emergency Preparedness:

3. School Events:

- For the month of May, students are being assessed on their flexibility, muscle strength and cardio output using the FITNESSGRAM (California Department of Education).
- On May 6th, students used water colors and Sharpies to make Mother's Day gifts.
- On May 7th, students cashed in on their puffball earnings and chose to celebrate their victory with a popcorn and movie party.
- Students have been weeding the garden and track area.
- Fourth grade students will be working on a California mission report.
- Fifth grade students will be working on an animal report.
- CAASPP testing for students in grades 4-5 began the week of May 3.
- Students wrote thank-you notes to the school nurse, an individual who donated to next school year's enrichment program, and the Greater Farallones.

4. School and Staff Development Updates:

- On April 28th, there was an after school parent check-in. During the parent meeting, families were asked to cast their vote for the naming of the district. From what people have shared with me, "Marin Rural School District" is in the lead. Also, during the meeting, parents asked about the play structure and school doors. The last parent check-in for the 2020-2021 school year is tentatively scheduled for May 19th.
- On May 3rd, I met with a family who is interested in having their incoming 3rd and 5th grade children attend Lincoln School for the 2021-2022 school year. They have followed up their interest with an interdistrict transfer release from NUSD.

- On April 21st, Danny (MCOE), updated Lincoln's operating system and added a secure browsing app to the Chromebooks for CASSPP testing.
- I've been working on preparing student materials for next school year. With the board's permission I would like to order Scholastic News, Keyboarding without Tears, and IXL. Also, will the professional experts from this school year be offered contracts for next school year?
- Parent and student surveys were gathered and reviewed. Overall, parents are content with the quality of instruction, consistency of communication, and well-being of their child/ren. The student surveys showed they feel safe, listened to, supported, and cared for in a clean, friendly school environment. Their top two choices for enrichment activities were cooking and art.

5. Other/Campus Maintenance:

- Jim has an update regarding the replacement of the school doors and repair of the outdoor play structure.
- Since the water pump issue last month, the water pressure from the main hand washing station is not offering enough water pressure for students to wash their hands efficiently. Should I call Arollo, a plumber, or is there a different recommendation that would resolve the issue?
- Thank you Sam for hanging a new flag on our flag pole. It looks great!
- As requested in the last board meeting, I reached out to Mazzoni and Associates regarding having emails from the website directed to me. Unfortunately, the emails are not being tracked. To test this, I sent an email using the "Contact Us" tab on Lincoln's current website from two separate emails, one from work, and the other from my home email address. I waited a few days, then contacted Josh and asked him if he received the emails I sent. He said he did not receive the emails because the Mazzoni website was asked to be disabled. He did some research, but doesn't know where the emails would have landed. Is it possible to have someone from the MCOE tech department reroute the "Contact Us" tab? As of now, if an interested family were to request information about Lincoln School, their email could be sent, but not read by anyone, causing no follow up to occur.
